



Parent Agreement

1. All necessary registration forms must be current and complete with accurate information upon enrollment. It is the responsibility of the parent or legal guardian to keep these forms current throughout the child's enrollment in our center. Should these forms not be kept current, your child may be denied attendance at the school.
2. Parents are responsible for transportation of their children to and from New Wonders Learning Center, Inc. If your child is transported to and from Wonders Learning Center, Inc. other than by the parent or legal guardian, the parent or legal guardian assumes all responsibility and arrangements.
3. Other than the parent or legal guardian, children will be released only to the person whose names are listed (by parent or legal guardian) on the Pick-Up/Visitation Denial Authorization Form. If a person not listed on the original form is to pick up the child, parents must notify the center Director.
4. Parents must provide their child's current medical and immunization records prior to enrollment. Medicals must be kept current and updated **annually**. It is the responsibility of the parent or guardian to keep these forms current throughout the child's enrollment in our center. Should these forms not be kept current, your child may be denied attendance at the school.
5. New Wonders Learning Center, Inc. must be informed of any changes related to the information in your child's folder. Should a change in information occur and New Wonders Learning Center, Inc. is not informed, the center cannot be held liable for decisions regarding your child's well being.
6. I give permission to New Wonders Learning Center, Inc. to make whatever emergency (first aid, disaster, evacuation, etc.) measures deemed appropriate for the care and protection of my child while under the supervision of the center.
7. Should my child become ill, New Wonders Learning Center, Inc. will notify me at all available numbers provided, and I will pick up my child immediately. My child will be able to return back after being 24hrs symptom free.
8. New Wonders Learning Center, Inc. reserves the right to close the school in the event of severe or potentially severe weather OR center emergencies. Additionally, if the center closes for facility or weather-related problems, parents are responsible for the full tuition.

9. A calendar of school closings will be provided to you during the month of September of each year.

10. Should your account be referred to a collection agency or an attorney for collection, you will be held responsible for all the collection costs, including attorney's fees and court costs.

11. If you have more than one child in the program. There will be a 10% discount on the lowest tuition. However, this discount does not apply to any additional fees other than tuition and cannot be combined with multiple discounts.

12. All children must have two changes of clothing left in the center to be used if needed. All clothing must be labeled with the child's name. The center is not responsible for lost or damaged clothing.

13. If a child brings any toys or other belongings to the center, the center is not responsible for loss or damage to those belongings.
